**REGULATIONS** made by the Ministry of Agriculture and fisheries in exercise of the powers conferred upon him by section 15 of the Pesticides Control Act, Chapter 181B of the Laws of Belize, Revised Edition 1980-90 and all other powers thereunto him enabling.

Provided that the Board shall only refuse to issue a licence if the person does not meet any or all of the requirements specified in Schedule III or Schedule IV hereto.

6. A person applying for a certified user's licence shall pay the following fees when submitting his application to the Board: -

- (a) initial application for a certified user's licence.....\$5.00
- (b) application for renewal of a certified user's licence......\$5.00

7. A person whose application for a certified user's licence has been refused by the Board and who is aggrieved by the Board's decision shall appeal against the Board's decision to the Minister within 30 days of his receipt of such decision, and the Minister's decision thereon shall be final.

8. The Board shall keep a Register of Certified Users, which shall be in the form specified in Schedule IV hereto.

9. A person who contravenes the provisions of these Regulations commits an offence and shall be liable on summary conviction to a fine not exceeding one thousand dollars or to imprisonment for a term not exceeding twelve months or to both such fine and imprisonment.

10. These Regulations shall come into force on the 15<sup>th</sup> day of August, 1996.



# SCHEDULE 3 (Regulations 2 & 5)

# REQUIREMENTS TO BE SATISFIED FOR LICENSING AS A USER OF RESTRICTED PESTICIDES.

To obtain authorization from the Board, the applicant shall satisfy the Board that he can: -

(*a*) read and understand the label of the type specified in the Registered and Restricted Pesticides (Registration) Regulation, 1995, following dosage, application and precautionary direction therein.

(b) understand general principles of safe and effective pesticide use, storage and disposal;

(c) safely and adequately prepare the mixture to be applied;

(d) calibrate and maintain knapsack sprayer;

(e) calibrate and maintain other specialized application equipment to requirements;

(f) choose and use the specific (**appropriate**) pesticide(s) required for his business

(g) understand responsibilities towards clients, employees and the public.
