1. These Regulations may be cited as the

Short Title.

REGISTERED AND RESTICTED PESTICIDES (MANUFACTURE, IMPORT AND SALE) (AMENDMENT) REGULATIONS, 1996.

and shall be read and construed as one with the Registered and Restricted Pesticides (Manufacture, Import and Sale) Regulations, which are hereinafter referred to as the principal Regulations.

- 2. Regulation 2 of the principal Regulations is hereby amended: -
- Amendment of Regulations 2.

- (a) by the repeal of paragraph (b) thereof;
- (b) by the repeal of paragraph (d) thereof and its substitution by the following: -
 - '(d) "import licence" means a licence for the importation of pesticides.'
- 3. Regulations 4 of the principal Regulations us hereby amended by the repeal of sub regulation (1) **(d)** thereof and its substitution by the following: -

Amendment of Regulation 4.

"(d) importation of pesticides –

I.	Value of imports less than \$1000.00\$25.00
II.	Value of imports of \$1001.00-\$2500.00\$50.00
III.	Value of imports of \$2501.00-\$4000.00 \$75.00
IV.	Value of imports of \$4001.00-\$5000.00\$100.00
V.	Value of imports of \$5001.00 or more 2% CIF value."

Amendment of Schedule.

4. The Schedule to the principal Regulations is hereby Amended by repeating Forms I and II thereof and substituting Therefore Forms I and II appearing in the Schedule to these Regulations.
